WHEREAS, the North St. Louis Soil & Water Conservation District received Board of Water & Soil Resources (BWSR) funding in 2021 on behalf of the Area 3 Technical Training Team for area-wide technical training of which \$3,685 remains for training costs and \$70.19 for administration: and

WHEREAS, there the Area 3 Technical Training Team has identified sustainable land care training as a need; and

WHEREAS, Blue Thumb has submitted a quote for 20 SWCD or NRCS employees to attend five online modules & two days of in-person training on this topic at a cost of \$8,585; and

WHEREAS, the BWSR has authorized a joint powers agreement for an additional \$4,900 in contracted training and \$300 for administration in order that the District contract with Blue Thumb for sustainable land care training; and

WHEREAS, the North St Louis Soil & Water Conservation District Board desires to accept this BWSR funding and enter into contract with Blue Thumb to provide the training.

NOW THEREFORE BE IT RESOLVED that the North St Louis Soil & Water Conservation District Board of Supervisors authorizes the District Administrator or Board Chair to sign all documents for the joint powers agreement with BWSR, and

BE IT FURTHER RESOLVED that the North St Louis Soil & Water Conservation District Board of Supervisors authorizes the District Administrator or Board Chair to sign the contract with Blue Thumb to provide sustainable land care training.

# Resolution to Authorize FY24 DNR Groundwater Contract

WHEREAS, the Minnesota Department of Natural Resources has four observation wells they desire to be monitored within the District boundaries; and

**WHEREAS**, the North St Louis Soil & Water Conservation District's 2023-2025 Strategic Plan identified "Create a work plan that capitalizes on staff strengths and optimizes funding opportunities" as a priority; and

WHEREAS, the North St. Louis Soil & Water Conservation District Board of Supervisors recognizes the \$30 reimbursement rate per reading does not cover costs if staff were to take readings; and

WHEREAS, Chuck Bainter, Frank Modich, and Mark Peterson volunteer to take the measurements and may use district vehicles to do so; and

**WHEREAS**, the Minnesota DNR has authorized these members of the Board Supervisors to take the readings eight times per year at \$30 per reading;

**NOW THEREFORE BE IT RESOLVED** that the North St Louis Soil & Water Conservation District Board of Supervisors supports DNR Groundwater measurements and authorizes the District Administrator or Board Chair to sign all documents related to such funding.

WHEREAS, the North St. Louis Soil & Water Conservation District accepted a 2022 USDA Natural Resources Conservation Service Conservation Collaboration Grant for the Arrowhead Forest Partnership (Board Resolution 2022-11) in the amount of \$400,000, and

WHEREAS, the Carlton, Cook, Lake, and North St. Louis SWCD's make up the Arrowhead Forest Partnership and provide forestry services to landowners applying for USDA NRCS Environmental Quality Incentives Program (EQIP), and

WHEREAS, the grant agreement currently funds one regional farm bill forester position who is handling the existing workload, and

WHEREAS, the Inflation Reduction Act of 2022 allocates a significant increase of EQIP funding over the next four years, and the USDA Natural Resources Conservation Service (NRCS) estimates that will double to triple funding available to Minnesota landowners, and

WHEREAS, NRCS and North St. Louis SWCD see the need for another regional farm bill forester position to handle the added workload, and NRCS will allocate additional funds to pay for the position, and

WHEREAS, the North St Louis Soil & Water Conservation District Board desires to add another staff member and accept this funding to provide services related to its mission.

NOW THERE BE IT RESOLVED, the North St. Louis Soil & Water Conservation District Board of Supervisors accepts said funding and hereby authorizes the District Administrator or Board Chair to sign all documents related to said funding.
